Background

Large events such as conventions, tradeshows and weddings have been hard hit by COVID-19 pandemic shutdowns. Event Protect™ was developed to establish consumer confidence in shows, create a safe environment for event participants and workers and help groups advocate for increased guest capacities.

Solution

Event Protect™ leverages BYOD™-powered AI technology to safely conduct large events with a rapid pre-admission health check questionnaire and a temperature verification at the point of check-in. It streamlines guest check-in processes and ensures that guest and employee safety is quickly and efficiently checked, monitored and recorded throughout the event both geographically and chronologically.

The Event Protect™ Process



Pre-Event Activities:

- Collect participant registration information (name, phone number, email address) prior to the event in an Event Protect™ Excel template.
- Registration information is uploaded into the Event Protect™ system.



Event Day Activities:

- Checkpoints will be set up at the event entrance. The number of checkpoints will be determined by the number of participants and the number of openings.

- When attendees are checking in, health check responses are confirmed, and their temperature is recorded. Both of these data points are logged in to an encrypted cloud server.
- The entire process takes 10-15 seconds per participant.
- When they pass the health screening and the temperature verification, they are allowed entry into the event. Should the participant fail either the health screening or temperature verification, the individual will be denied access to the event.



Post-Event Activities:

- Easy reporting provides a record of the attendees and the health screening results.
- In the case of a COVID-19 episode, Event Protect™ provides the participants' information and the date and time they entered the event. This will enable a local health department to contract trace if required.
- This information is owned and managed by the Event Administrator.
- Event Protect™ complies with all HIPAA identity protection frameworks.

Key Benefits

- Event Protect™ requires that every participant be screened before entry; only those passing the screening will enter the event.
- Event Protect only takes seconds per participant.
- Event Protect™ captures, encrypts and stores all data in a secure AWS cloud environment. Only the Event Administrator has access to this information.
- The application runs on both iOS and Android operating systems.
- Event Protect™ complies with CDC, state and local COVID-19 guidelines.

Advocacy

- The screening, reporting and auditing capabilities of Event Protect™ will allow venues to lobby for the same indoor capacities as restaurants while following all social distancing and sanitization guidelines.
